

Tearful Nation Bids Final Farewell to Sublime Sushmaji

New Delhi

The last rites for Sushma Swaraj, the former foreign minister and a BJP stalwart, were conducted Wednesday to the sounds of ceremonial bugle and Vedic mantras, the widely different tunes emblematic of the woman herself who harmonised many different chords in her persona.

Swaraj, one of India's most high profile woman politicians who died on Tuesday night, combined her hard-nosed politics with compassion and empathy, winning admirers across the political spectrum and among ordinary people whose lives she touched often, sometimes personally and often through social media.

The 67-year-old veteran BJP leader and former External Affairs minister, always distinctive with 'sindoor' and a large 'bindi', brought a human approach to India's diplomacy.




The mortal remains of former external affairs minister Sushma Swaraj were consigned to flames on Wednesday as Prime Minister Narendra Modi and other senior leaders, besides family, friends and admirers bid a tearful adieu to the political stalwart. A sea of mourners had gathered at the Lodhi Road crematorium here where she was cremated with full state honours. Swaraj, one of India's most high-profile woman politicians, who brought a rare empathy and a human approach to India's diplomacy, died at AIIMS here late Tuesday night, plunging the nation in a state of grief. The body of the former minister, wrapped in a tricolour, was brought to the crematorium in the afternoon from the BJP headquarters, where it was kept for few hours for people to pay their respects. Hundreds of people, including the prime minister, Vice President M Venkaiah Naidu, BJP chief Amit Shah, veteran party leader L K Advani, Delhi Chief Minister Arvind Kejriwal and Assam Chief Minister Sarbananda Sonowal, Union ministers Rajnath Singh Harsh Vardhan and Ashwini Kumar Choubey, BJP working president J P Nadda, and New Delhi MP Meenakshi Lekhi bade her an emotional farewell.

BJP MPs celebrate passage of resolution on Art 370 in LS

New Delhi

BJP MPs in Lok Sabha on Tuesday celebrated with loud slogans of 'Bharat Mata Ki Jai' and thumping of desks as the House passed the Jammu and Kashmir reorganisation bill and a resolution on Article 370.

The mood among the treasury benches during the debate was boisterous with Home Minister Amit Shah joining the members in the applause several times as the MPs gave their speeches.

Prime Minister Narendra Modi too was greeted with loud cheers and slogans by BJP members when he arrived in the House just before Shah was to respond to the debate on motion to abrogate special status to Jammu and Kashmir and a bill which splits the state into two Union Territories.

As soon as the Bill and the resolution were passed, BJP MPs got up from their seats and started thumping the desks amid sloganeering.

After Lok Sabha was adjourned sine die, members came to Shah's seat to congratulate him and greet Prime Minister Narendra Modi.

Later Modi walked to-

wards opposition benches and shared greetings with leaders including BJD's Pinaki Misra, TRS' Nama Nagaeshwar Rao and briefly interacted with SP patriarch Mulayam Singh Yadav.

Modi also patted BJP's Ladakh MP Jamyang Tsering Namagyan for his speech on the resolution and the bill.

When some opposition members took exception to the sloganeering, Shah said such slogans are being raised in every village of the country and the opposition should not have any objection.

Newly appointed Mumbai president of the Nationalist Congress Party (NCP), Nawab Malik, on Tuesday said his party does not depend on leaders, but on voters and workers who work hard for its victory. "We are confident that we still have the support of voters and we will show that in the elections," said Mr. Malik, who took charge of the Mumbai unit on Tuesday. On the recent exodus from the party, especially of his predecessor Sachin Ahir who joined the Shiv Sena, Mr. Malik said his party never depended on 'aayarams and gayarams' (people who come and go). "Why should we bother about those who chose to desert us," he said. "The only way to grow the party organisation in Mumbai is that we become the voice of the people. Whatever the issue, and however local it may sound, we have to raise it. This is going to be our job and the NCP will become the party of the people of Mumbai," he said.

Six held for killing man in Kalyan

Thane

Six people were arrested on Tuesday for allegedly murdering a man in Kalyan in Thane district, police said.

The body of Jongol Budhwa Lohra (48) was found near an electric transformer under MFC police station limits in the early hours of the day, said Senior Inspector Prakash Londhe. "Lohra was killed between 2:30am and 4am with sharp weapons and sticks. The accused then dumped the body near the transformer and fled. They were arrested later in the day," he said. The official identified those arrested as Sandesh Jadhav, Navnath Rathod, Mangal Mangesh Hamal, Anish Shaikh, Nooralam Raju Jiprya and Popat Mama. A case under section 302 (murder) of the Indian Penal Code has been registered, he added.

Can't allow animal slaughter in flats on Bakr-Id: HC

Mumbai

The Bombay High Court on Tuesday restrained the Brihanmumbai Municipal Corporation from granting permission for slaughter of animals this Bakr-Id inside residential flats.

A bench of justices S C Dharmadhikari and G S Patel said it could not completely prohibit such slaughters within the compounds or grounds of housing societies.

However, the housing societies located within one km of religious plots and community halls, which could be used as alternate

within individual flats. Therefore, no permission can be granted for such slaughters within individual residential flats," the bench said.

The bench was hearing two petitions filed by local NGOs Jiv Maitri Trust and Viniyog Parivar, challenging the civic body's decision to grant temporary noobjection certificates to several housing societies for the slaughter of goats and sheep on Bakr-Id.

The petitioners argued that the civic body's policy violated the environmental and animal welfare laws.

BMC's counsel Anil Sakhre, however, told the the BMC to carry out the court that such slaughters were permitted as per its rules, and it was regulated by a very specific policy that imposed conditions on the area for such slaughters, compulsory enclosure of such space, maintenance of hygiene, and law and or-

Sakhre said it was a re-

could not accept the petitioners' argument that such slaughter be restricted to the abattoir located in Deonar area here.

He said specific arrangements would be made to dispose of the carcass and clean the slaughter area.

The bench, however, said permission must not be granted to individual flats for the slaughter of animals.

It said several community halls, grounds and even some religious sites in the city were used for such slaughter.

Therefore, such housing societies that were located close to such sites must not be granted permission to carry out slaughters inside their own premises. The court said suitable measures must be taken for transporting animals for slaughter and disposal of their carcasses. The BMC must ensure that hygiene was maintained and other residents were not inconvenienced, it further said.

President Ram Nath Kovind has declared abrogation of the provisions of Article 370 of the Constitution, which gave special status to Jammu and Kashmir.

The move came after both houses of Parliament passed a resolution in this regard. "In exercise of the powers conferred by clause (3) of Article 370 read with clause (1) of Article 370 of the Constitution of India, the President, on the recommendation of Parliament, is pleased to declare that, as from the 6th August, 2019, all clauses of the said article 370 shall cease to be operative...," an official no-

The BJP-led government's bold move to revoke the special status of Jammu and Kashmir and bifurcate the border state into two Union territories secured Parliament's approval on Tuesday with the Lok Sabha passing the new measures with an over two-

thirds majority. The Rajya Sabha gave its approval to the resolution on Monday.

The government had announced on Monday the removal of some provisions of Article 370 to take away Jammu and Kashmir's special status and proposed bifurcation of the state into two Union territories --Jammu and Kashmir and Ladakh -- a far-reaching decision that seeks to redraw the map and future of a region at the centre of protracted militancy.

With this, the ruling Bharatiya Janata Party (BJP) has fulfilled one of its poll promises within 90 days of the Modi government 2.0 taking charge.

Across State Ayodhya case in SC: Hindu party seeks control of entire 2.77 acre disputed land

New Delhi

A Hindu body on Tuesday strongly pitched in the Supreme Court for control and management of the entire disputed 2.77 acre land in the politically and religiously sensitive case of Ram Janmabhoomi-Babri Masjid title dispute at Ayodhya.

Nirmohi Aakhara, one of the leading parties in the case, asserted its claim over the disputed site where the medieval structure was demolished on December 6, 1992, and said that Muslims have not been allowed to enter the place since 1934.

The Hindu body said it was claiming ownership and possession of the "main temple" as also to be the manager of the birth place of Lord Rama.

The top court, which commenced the day-to-day hearing Tuesday following the failure of the mediation proceedings to resolve the dispute amicably, was told by the Hindu body that since time immemorial "Janma Asthan now commonly known as Janam Bhumi, the birth place of Lord Ram Chandra was belonging to and in possession of the Akhara".

Nirmohi Akahara submitted before a five-judge Constitution bench headed by Chief Justice Ranjan Gogoi that it was also acting as "its (property) Manager" through its 'Mahant' and 'Sarbrahkar' who had been managing and receiving offerings made there at in the form of money.

The bench, also comprising Justices S A Bobde. D Y Chandrachud, Ashok Bhushan and S A Nazeer,

His successful piloting of the move to strip Jammu and Kashmir of its special status is undoubtedly the highlight of his ministerial stint since the Modi 2.0 government assumed office on May 30.

Parliament's nod to the bills to strengthen anti-terror laws during the ongoing session has also bolstered his image on two planks close to the saffron parivar: Hindutva and national security.

After Prime Minister Narendra Modi, Shah is getting the credit for bringing to fruition a cause for which the BJP ideologue Syama Prasad Mookerjee



died in a Jammu and Kashmir jail in 1953.

While BJP leaders were expectedly fulsome in praise of Shah in their speeches in Parliament, with some likening him to first home minister Sardar Patel, speakers from even parties outside the NDA fold like the YSR Congress were no less enthusiastic in

He has been instrumental in winning over leaders from the opposition, bagging support from non-allied parties and turning the numbers on their head in Rajya Sabha.

On paper, the BJP-led NDA still lacks a majority in the Upper House but the bill to bifurcate Jammu and Kashmir into two states received 125 votes in favour and only 61 against it on Monday.

Political pundits say Shah has used a skilful mix of ideological firmness, unlimited political imagination and realpolitik flexibility to keep the BJP ahead of the game.

Modi critic Bhagawan praises **PM for Govt's Kashmir move**

Controversial left leaning litterateur and historian K S Bhagawan, a staunch critic of Prime Minister Narendra Modi, has heaped praise on him for government's move to revoke Article 370 giving special status to Jammu and Kashmir.

The decision has rid the people Kashmir of their sufferings and brought happiness to the country, Bhagawan said.



Justifying applauding Modi on the issue, Bhagawan said whatever is good for the country should be appreciated.

'What former Prime Minister Atal Bihari Vajpayee could not do, was made possible by Modi, which everyone should welcome," he said.

The controversial author was rertedly in the hit list of a "right wing gang", which was allegedly behind the killing of journalist Gauri Lankesh and rationalist M M Kalburgi, following which his security was strengthened. Bhagawan had drawn flak in February 2015 when he allegedly stated that certain stanzas of the Bhagavad Gita should be burnt as they promote caste-based discrimination against the "Shudras" or the lowest strata of Hindu society.

Naxal leader on the run held in Telangana

A leader of the armed underground 'dalam' (group) of CPI (ML) New Democracy was arrested on Tuesday and a .303 rifle along with ammunition was seized from him, police said D Sammaiah (50) was apprehended in the forest area of Raigudem in theBhadradri-Kothagudem district of Telangana, superintendent of police Sunil Dutt said. The naxal, wanted in 13 criminal cases in different police stations, was caught while police were searching for dalam members who were involved in firing at a police party in

Bhadradri-Kothagudem district on July 31, they said. In the firing, Linganna, state secretary of the CPI (ML) New Democracy, and the "Commander of the Linganna Dalam", the underground group formed by him was killed. Of late, the naxalites have been camping in the forest area of Gundala mandal with a view to extorting money from contractors and businessmen. Besides, the naxal group was involved in inducing innocent tribals to indulge in illegal activities like cutting down of trees in the name of podu (slash and burn) cultivation.

Maharashtra Chief Minister Devendra Fadnavis on Wednesday took a break from his ongoing mass outreach programme and chaired a meeting here to review the flood situation in various parts of the state.

He directed the authorities concerned to make adequate arrangements of food, drinking water and other essential items for the flood-affected people in Kolhapur, Sangli, Raigad and Palghar districts, a statement from the Chief Minister's Office (CMO) said.

Western parts of the state witnessed heavy rains in the last few days, causing flooding at various places.

Nearly 53,000 people from Sangli district were shifted to safer places, while around 11,432 people were so far evacuated from Kolhapur and 3,000 from Raigad, the CMO said.

Governor Shaktikanta Das Wednesday termed the steeper 0.35 percent repo rate cut as a "balanced" call given the domestic and global developments.

He explained that a 0.25 percentage points reduction, as it has done thrice this year since February, would have been "inadequate", while a 0.50 percentage points cut would have been "excessive".

The six-member Monetary Policy Committee (MPC) for the fourth consecutive times in a 4:2 vote resolved to cut the rates by 0.35 percent, taking the total cuts during 2019 to 1.10 percent to a near record low of 5.40 percent. Das said the RBI has been pre-

cuts and also made it clear that the rate call cut has not been taken on "gut feel" but on hard data.

Too much should not be read into it, it is judgement call which the MPC has taken," he said, adding that it was "prudent" to be accommodative.

SBI lowers lending rates by 15 bps from Aug 10

Within hours of a steeper 35 basis points reduction in the repo rates by the Reserve Bank to 5.4 percent in its fourth consecutive steps, the largest lender State Bank announced a 15 basis points reduction in its lending rates, effective August 10 across all tenors.

The new one-year MCLR or the marginal cost based lending rates will come down to 8.25 percent from 8.40 percent annum, the lender said in a statement. With this reduction, the bank's effective repo-linked lending rate (RLLR) for cash credit accounts (CC)/ overdrafts (OD) customers will be revised downwards to 7.65 percent, from September 9. After this cut, home loans of the bank have become cheaper by 35 bps since April. The bank is offering a repo linked home loans from July 1, 2019.

Mumbai

The Bombay High Court on Tuesday said there are many lacunae in the probe carried out by the Mumbai Crime Branch in the death of 26-year-old Payal Tadvi and said the "medical profession was no longer noble."

A Single Bench of Justice Sadhana Jadhav was hearing bail applications filed by Dr. Hema Ahuja (28), Dr. Bhakti Mehare (26) and Dr. Ankita Khandelwal (27), all thirdyear resident doctors at BYL Nair Hospital currently lodged at the Byculla prison for allegedly harassing, ragging and abetting the suicide of Tadvi, who belonged to a Scheduled Tribe.

When special public prosecutor Raja Thakare was reading the charge sheet, Justice Jadhav said, "Look at the number of authorities that [Tadvi's] mother went to raise a complaint ... Dr. Yi Ching Ling, who heads the obstetrics and gynaecology department at the BYL Nair Hospital has clearly shirked responsibility by refusing to



take cognisance of a complaint of harassment made by Tadvi's mother, and therefore, she must be added to the list of the accused persons in the case."

The court then directed the police to initiate proceedings to seek necessary permissions to take action against Dr Ling.

After being pulled up by the court for not recording statements of relevant witnesses, Mr. Thakare said the Crime Branch will take all steps to record statements of doctors Snehal Shinde, Geeta Kulkarni, Ziyan Sayyad, Anupama Kanwar, Devika and Surabhi by August 9 under Section 164 (recording of confessions and statements) of the Code of Criminal Procedure.

The court directed the chief metropolitan magistrate "to take expeditious steps to see the statements are recorded at the earliest."

The court, however, said the comparison with homicide or murder did not fit the case as the accused had inflicted continuous mental injury on the deceased.

Justice Jadhav said, "Often it is said that physical injury is better than mental injury for the latter goes unseen and is left untreated. However, in the present case there are no assumptions. The deceased and her family raised several complaints before the suicide, the mental injury was seen and it could have been curtailed, yet, no one too serious note of it. You can't say, thus, that this is micide for mental injury was inflicted upon her," the court said.

Referring to the conduct of the doctors, the court said, "Everyone merely said this is common in medical colleges. What kind of attitude is this where doctors [behave] like that? This profession is no more noble." The prosecution also made a request before the court that media should be prohibited from reporting on court proceedings in the case. The defence consented to it, but the judge said an order will be passed on this later. The court added that the prosecution must keep in mind that another Bench of the HC had revoked a media gag order on the Sohrabuddin Shaikh fake encounter case.

Tadvi killed herself in her hostel room on the hospital's premises on May 22. The three doctors was sent to judicial custody on May 31 and subsequently filed their bail pleas. Their pleas were filed in HC on June 29 after the city civil and sessions court refused to grant them bail on June 24.

A bench comprising Justices

Arun Mishra, M R Shah and B R Gavai asked several states, which have not yet filed affidavits giving details about the procedure adopted in rejecting the claims, to file their responses by September 6.

'Nine states say they have not followed the procedure. We would like to be addressed first on this. It is an important matter," the bench observed and posted the case for hearing on September 12.

The apex court had earlier stayed its February 13 order directing 21 states to evict 11.8 lakh illegal forest dwellers whose claims over the forest land have been rejected by the authorities.

Across State Parliament passes new Consumer Protection Bill

New Delhi

Parliament on Tuesday approved a new bill to revamp the process of administration and settlement of consumer disputes, with stiff penalties including jail term for adulteration and fines for misleading ads.

The Consumer Protection Bill 2019, already passed by Lok Sabha, was approved in the Upper House by voice vote and will replace the Consumer Protection Act. 1986.

Motions moved by Derek O Brien (TMC) and K K Ragesh (CPI) for sending the bill to a select committee of Rajya Sabha for further scrutiny were rejected by the Upper House.

Members from Left parties, DMK and Trinamool Congress alleged the bill takes away indirectly the powers of the state governments and should be referred to a select committee

The bill piloted by Union Food and Consumer Affairs Minister Ram Vilas Paswan seeks to establish a Central Consumer Protection Authority (CCPA) to promote, protect and enforce consumer rights.

Under the Bill, celebrities endorsing misleading ads are also liable for fine.

The Bill strengthen the rights of consumers and provides a mechanism for redressal of complaints regarding defects in goods and deficiency in services.

Replying to a debate on the Bill, Paswan said that the suggestions given by members would be included in the rules framed by the Ministry under this legislation.

The minister said if a product is found faulty, instead of earlier individual examination, the entire batch would be examined.

He said the new bill seeks to take care of product liabilities and service, as well as action against publishers and celebrities of misleading advertisements.

Paswan said there are a number of pending cases, over 20,304 cases at national level, 1,18,319 cases at state level and 3,23,163 cases at the district level, in the



ing celebrity endorsements raised by Samajwadi Party member Jaya Bachchan, Paswan said when the Bill was sent to a Standing Committee earlier, it set jail term as punishment. However, later when an assessment was conducted, it was found that world-wide there is no provision of serious punishment for celebrities. Paswan observed that media and celebrities must only advertise what has been given in writing to them by manufacturers, else they will be responsible (for the misleading advertisements). The minister was quick to add that celebrities were also endorsing Swachhta campaign and other social messages.



Rao also pointed that the bill has not been drafted in a "simple language" for the benefit of consumers. The definition of consumer rights is written in a complicated way, he said

Speaking in favour of the bill, Ravi Prakash Verma (SP) demanded that the government create a consumer-friendly ecosystem in the country and create more awareness about consumer rights. Amar Patnaik (BJD) said the bill is good but several things need to reconsidered, especially definition of consumer should be broadened. He welcomed the provision on class action. Supporting the bill, Kahkashan Perween (JD-U) shared her bad experience of buying diabetes medicine from an online platform.

The bill has provisions for deterrent punishment to check misleading advertisements and adulteration of products. It also enables regulations to be notified jurisdiction of which he resides. Experts in literacy and child development have discovered that if children memorize eight nursery rhymes by the time they are four years old, they are usually among the best readers by the time they are eight. (Fox, M. (2001). Reading Magic. San Diego, CA: Harcourt.)

The poems that I memorized as a child, my teachers and the memories related to them are till today fresh and unfazed in my mind. When I began teaching, I enjoyed creating simple poems based on the topics to be taught. This made it easy and interesting for my students. I felt good when I got encouraging results from students.

Confucius (551 BC- 479 BC) said, "I learn and I forget, I see and I remember, I do and I understand." Based on this philosophy I developed creative writing activities on the 31 poems I wrote. Each activity is designed keeping in mind children's imagination and devel-

opment of their creative writing skills. Students will find these activities very refreshing and helpful in developing their vocabulary in all the languages they are learning, including their mother tongue.

The activities are based on principles of constructivism, a learning theory found in Psychology which explains how people think, acquire knowledge and learn. The theory suggests that humans construct knowledge mainly from their own experience of learning. I realized that this is

a sure way to make children learn through constructive approach. Therefore, this creative writing workbook will be useful for the students to think and express themselves based on their own experiences. Students of vernacular medium who want to improve their English language skills will also find the book useful. These simple poems are easy to memorize. Students can even sing them on tunes composed by them. These activities will also help students to improve their creative thinking skills. Some of the qualities students will develop will lead to lifelong learning. The students will be able to develop their creativity and writing skills. They will be able to understand and appreciate poetry as a

Abrogation of Article 370, implementation of the uniform civil code and building a Ram temple at Ayodhya have been the cornerstones of the BJP's political programme and prime promises in its poll manifesto over many decades. Of these, abrogation of Article 370 of the Constitution that gives a special status to the state of Jammu and Kashmir has been the oldest ideological argument of the RSS and its political offshoots, the Jan Sangh and the BJP. Jan Sangh founder Syama Prasad Mookerjee had quit Jawaharlal Nehru's Cabinet in 1950 primarily over this issue. This special status was offered at a time when most princely states, which had acceded to the Indian Union, still hung on to old practices, hierarchies and bureaucracies; when former rulers were termed Raj Pramukhs and their coats of arms and flags were in vogue. Sheikh Abdullah wanted this status to convince and reassure his people to join a Hindumajority nation and Nehru offered it to enhance the prestige of a multicultural, diverse India and to defeat Jinnah's identity politics

Now, after seven decades, J&K loses its special status and gets reorganised into two union territories: one for Ladakh and the other for the divisions of Jammu and Kashmir. This doesn't come as a surprise because the RSS had passed a resolution in 2002 seeking the trifurcation of J&K into three administrative units comprising Jammu, Kashmir and Ladakh. It cannot be a coincidence that the Centre has moved the resolution to abolish Article

370 in the Rajya Sabha on Monday, soon after criminalising triple talaq — a step in the direction of a uniform civil code. So, of the core issues of the Sangh Parivar, only the Ram temple is now left on the table.

The BJP can claim that it is merely fulfilling its election mandate; the promises it has made to its voters all these years and particularly during the highly polarising General Election, which concluded less than three months ago. But has the government thought it through? Has it factored in all the international ramifications, the UN resolutions and the neighbourhood's response? The government, at home, could have acted with a lot more transparency in Delhi and in the Valley.

UAPA Amendment Bill

THE Unlawful Activities (Prevention) Amendment Bill passed by Parliament, allowing the Central Government to designate an individual as a terrorist and seize his property, is likely to generate a controversy because of the powers it confers on the National Investigation Agency (NIA). The Bill has been justified on the ground that even after banning an outfit, a terrorist can float another group ing sweeping powers to the law-enforcement agenand continue with his activities and that countries like the US, China and Israel have similar laws. Predictably, as such laws do, it will lead to apprehensions over the rights of an individual and civil liberties. If the government believes an individual is involved in terrorism, he can be declared a terrorist sans an FIR, charge sheet or trial in a court. Usually, an individual is presumed innocent until proven guilty, but here the onus will be on the person to prove he is not involved in terror activities. The NIA is believed to have asked for the amendments because such cases have inter-state and trans-national implications. But investigative

agencies in India already have questions to answer. The CBI, like in the Aarushi case, was accused of first zeroing in on individuals and then finding evidence to nail them. AFSPA, too, is open to the allegation of misuse despite the need for it in areas affected by insurgency. The UAPA Bill is reminiscent of MISA during the time of Indira Gandhi, givcies, including preventive detention and seizure of property. We live in a neighbourhood where the danger of terrorism lurks, the Mumbai terror attacks that led to the creation of NIA are its most potent reminder. Designating individuals will help notify the names of suspects, but the test will lie in separating the wheat from the chaff. The NIA has asked for an in-camera trial in the Malegaon case to ensure communal harmony and the security of witnesses. As charges of vendetta against individuals and communities may crop up, lending the law to greater scrutiny will mean more responsibility and also more accountability.

Krishna, the Ever Youthful Cowherd Boy

In the Brahma-samhita (5.33) you will find Krishna described as advaita and acyuta. Adwaita means absolute, and acyuta means infallible, or Brahman. He is Parambrahman. We are also Brahman, spirit, but we have fallen down into this material condition. But Krishna never falls down into the material condition. When He appears before us, don't think, "He is also a fallen soul like me." The fools consider like that. Avajananti mam mudha (Gita 9.11). Mudha means fools. The fools consider Krishna an ordinary man. Param bhavam ajanantah. The fools do not know of the immense potency of Krishna. Therefore they think of Krishna as one of us.

Krishna is sarva-adi, the primal. And sarva-amshi means He is the original of whom everything else is part. We are also part and parcel of Krishna, just as the hand is part of the body. We can understand the concept of part and whole. He is the whole, and everything else is His part.

Krishna is kishora-shekhara, "the supreme boy." He is just like a fresh is defined as having no length and no breadth, because a point cannot be measured by any human instrument. But nothing can be without shape. Even the atom has its measurement. But because we have no power to measure something, we set its measurement aside, dismiss it: "Oh, there is nothing." And we foolishly conclude, "Because we do not know what is spirit and we think spirit is something that is just the opposite of matter, which has form, therefore spirit should be formless.'

But actually it is not so. We therefore require to learn from the authority. Lord Chaitanya says, chid-anandadeha: Krishna has a transcendental, eternal body. And sarvashraya: He is the resting place of everything.

You see before you that so many big planets and the sun are floating in the air. The sun is such a big body, some millions of times greater than the earth, and it is floating in the sky. How? Here it is explained. Sarvashraya: It is floating on Krishna's energy.

Sarveshvara, the next word in this verse, means the Supreme Lord. Lord Chaitanya is explaining everything very nicely. Sarva-adi: Krishna is the origin of everything. Sarva-amshi: He is the whole of all the parts. Kishora-

of material nature, which is pulling you by the ear. You are being influenced. It is like you've been thrown into the Atlantic Ocean. You have no power. The waves are tossing you this way and that way. You are simply struggling. That's all. How can we think we are acting independently when we are tossing in the Atlantic Ocean? Such thinking is all nonsense.

We cannot imagine, we cannot concoct, ideas about God. We have to hear from authoritative scripture. Then we will understand. Here is authoritative information from the Brahmasamhita (5.1):

ishvarah paramah krishnah sach-chid-ananda-vigrahah anadir adir govindah sarva-karana-karanam

'Krishna, who is known as Govinda, is the Supreme Godhead. He has an eternal blissful spiritual body. He is the origin of all. He has no other origin, and He is the prime cause of all causes." There are many lords. We have got experience. In England you will find many lords. In our youth we had some dealings with Lord Zetland. the Marquis of Zetland. In your country also there are many lords. Any rich man is a lord. In our country also there are many lords. But Krishna is not a lord like them. These lords are under the grip of material nature. They are lord by name. But as soon as the material nature gives a slap on the lord, at once he has passed, and everything vigrahah. And He is anadi, without beginning. We have experience that everything has its cause. Suppose I am a lord. Then I had some cause to become a lord. Either my father was a lord, or I have accumulated some wealth, or the government has recognized me as a lord. I have become a lord under certain conditions. But Krishna is adi. Adi means He is the origin. There is nothing beyond Him.


Anadir adih. Everything has a cause, but He has no cause. He is the Lord, but there is no cause by which He has become the Lord. When I am a lord, there is a cause. Perhaps you know that in England, if somebody becomes very rich he has to deposit some amount of money to the government, and then the government will award him the title "lord." With that huge amount of money his family will be maintained after he dies, and then the first son of the lord's family will be declared a lord. This is what I have heard. I do not know exactly. But this lord is made, recognized, by the government on deposition of some certain amount of money. The government agrees, "Yes, this family may be recognized as a lord family." In England they create aristocracy. Similarly, when the British were in India, they created many aristocrats. Krishna is not a created, aristocratic lord. That we should know.

The Pleasure of the Senses, the Cow, and the Land

old boy playing with cows. His father has many cows, and He takes the cows and goes on a pleasure trip with friends. That is Krishna's business. He is not going to any office or any factory. You see? In the material world the cow is limited. There is a time when you can milk, morning and evening, and you get a certain quantity, not more than that. But you can milk surabhi cows anytime you like, and you can draw as much milk as you like.

Krishna is Govinda. He is giving pleasure to everyone. Go means senses. We are seeking sense pleasure. Sense pleasure means reciprocation between two people. I want to see a beautiful girl. That means two. Or I want to see a beautiful boy. So that means two. Without two there cannot be sense pleasure. I want to eat some-

The powerful orator leaves behind the legacy of an easily-accessible leader who played a key role in BJP's emergence in the late 1990s.

The commitment of a leader, who became an MLA for the first time when she was just 25 before going on to become Haryana's education minister, was there till the very end.

Hours before her death on Tuesday night, Swaraj was on Twitter, congratulating Prime Narendra Modi after the Centre's move to revoke the special status for Jammu and Kashmir.

"I was waiting to see this day in my lifetime," she said in her prescient message

A short while later, she died at the All India Institute of Medical Sciences after suffering a cardiac arrest.

Swaraj, who had a kidney transplant in 2016, had opted out of fighting the Lok Sabha elections this year due to health reasons

She was not part of the Modi government this time and S Jaishankar replaced her as the external affairs minister.

She will long be remembered for being that rare minister who exuded so much warmth that people didn't hesitate to reach out to her in times of need. Swaraj could be depended on to help out the diaspora in distress with her revolutionary social media outreach.

As the tributes poured in after her sudden death, there were many who remembered her as a mother figure.

New Delhi

India's sporting fraternity, led by cricket captain Virat Kohli, mourned the demise of former External Affairs Minister Sushma Swaraj, on Wednesday.

Swaraj passed away at the All India Institute of Medical Sciences (AIIMS) in New Delhi on Tuesday night after suffering a cardiac arrest. She was 67.

"Deeply saddened by the news of Sushma Ji's demise, may her soul rest in peace," Kohli wrote on his twitter page.

Sports Minister Kiren Rijiju said Swaraj will always live in the hearts and minds of the people.



Several path-breaking measures such as the passport infrastructure expansion and enhanced engagement with the East were the highlights of her tenure as the external affairs minister.

She was only the second woman to hold the portfolio after Indira Gandhi, who briefly kept the external affairs ministry under her while being the prime minister.

Swaraj had many firsts to her credit such as being the youngest cabinet minister in the Haryana government, first woman chief minister of Delhi and the first woman spokesperson for a national political party in the country.

She started her political life with the Akhil Bharatiya Vidyarthi Parishad, the RSS' student wing, and later joined the BJP.

She was the Information and Broadcasting minister in the 13-day Atal Bihari Vajpayee government in 1996 and got the Cabinet portfolio again after he led the BJP to power in 1998.

Always eager to take on a challenge, Swaraj contested against the then Congress president Sonia Gandhi in Bellary in 1999 Lok Sabha polls. Though she fell short of votes, she grew in stature.

Long seen as a protege of veteran BJP leader L K Advani, she also was Leader of Opposition in the Lok Sabha between 2009-14.

"She touched everyone with her warmth and compassionate nature. I do not recall

a single year when she missed bringing my favourite chocolate cake to me on my birthday," Advani said, remembering her fondly.

waraj had played a key role in BJP'e emergence as a strong political force in late 1990s.

Swaraj, a law graduate who practised in the Supreme Court, was elected seven times as a member of Parliament and three times as a member of the legislative assembly.

She also held the portfolios of Telecommunications, Health and Family Welfare, and Parliamentary Affairs in the Union Cabinet.

She was married to Swaraj Kaushal, a designated senior advocate of the Supreme Court of India who served as Governor of Mizoram from 1990 to 1993. Kaushal was also a Member of Parliament from 1998 to 2004.

Swaraj was also the recipient of the Outstanding Parliamentarian Award.

During her tenure as the external affairs minister, she handled several strategically-sensitive issues, including Indo-Pak and Sino-India relations.

Her role in resolving the prickly Doklam standoff between the Indian and Chinese sides will be remembered.

Swaraj's humanitarian touch in diplomacy including extending help to people in distress, both Indians and foreigners, won her love and respect at home and abroad including in Pakistan.

Though known to be a tough fighter in the political battlefield, Swaraj was admired and respected across party lines.

"I was so sad looking at the headlines in the paper today. I really really liked Sushma Swaraj ji. She was someone to look up to. She was a great leader, a great orator, a strong woman and true to her work. India will miss her deeply," Heena wrote.

Other cricketers such as Suresh Raina, Mohammad Kaif and Aakash Chopra also condoled her death.

"Fierce, result-driven and a people's person she was all of that and more. A true leader. Still unable to process the news of Sushma Swarajji's passing away. Extremely disturbed! A big loss for our nation. May you rest in peace!" said Raina. In his condolence message, Kaif wrote: "Here in the West Indies and just heard the terrible news of passing away of #SushmaSwarajji. Condolences to her family, gone too soon."

Former External Affairs Minister and senior BJP leader Sushma Swaraj passed away on Tuesday night, AIIMS sources said

She was 67.

The senior BJP leader was brought to AIIMS around 9:30pm and was straight away taken to the emergency ward.

AIIMS doctors said she died of a cardiac arrest.

"A glorious chapter in Indian politics comes to an end. India grieves the demise of a remarkable leader who devoted her life to public service and bettering lives of the poor. Sushma Swarai ji was one of her kind, who was a



source of inspiration for crores of people," Prime Minister Narendra Modi said in a series of tweets.

Several senior ministers, including Harsh Vardhan, Rainath Singh, Smriti Irani Prakash Javadekar, reached AIIMS after she was admitted to the hospital.

Swarai had put out a tweet in the evening congratulating Prime Modi after the Centre's move to revoke special status for Jammu and Kashmir and bifurcate the border state into two Union Territories secured Parliament's approval.

"Narendra Modi ji - Thank you Prime Minister. Thank you very much. I was waiting to see this day in my lifetime," she had said

The United States is trying to build up coalition for its Gulf expedition. The world power is finding a few friends while a few of its friends are not feeling easy with joining the war-coalition and the world power is facing problems in building up the war axis

U.S. allies feel 'ashamed', say Zarif

The U.S. is unable to build a naval coalition to escort tankers in the Gulf because its allies are too "ashamed" to join it, said Mohammad Javad Zarif, Iran's foreign minister.

"Today the United States in alone in the world and cannot create a coalition. Countries that are its friends are too ashamed of being in a coalition with them," Zarif told a news conference in Tehran Monday.

"They brought this situation upon themselves, with lawbreaking, by creating tensions and crises."

Tension is soaring after the Trump administration stepped up a U.S. campaign of "maximum pressure" against Iran.

Asked on Monday about reports that he had been invited to meet Trump in the White House, Zarif said he had turned it down despite the threat of sanctions against him.

"I was told in New York I would be sanctioned in two week unless I accepted that offer, which fortunately I did not," said the Iranian minister.

The New Yorker magazine reported on Friday that Senator Rand Paul met Zarif in the U.S. on July 15 and had Trump's blessing when he extended an invitation to the Iranian minister to go to the White House.

The U.S. imposed sanctions against Zarif on Wednesday, targeting any assets he has in the U.S. and squeezing his ability to function as a globe-trotting diplomat.

The U.S. has struggled to gain support for the coalition from European and Asian allies, who fear it would further stoke tensions with Iran. European countries are believed to be concerned about being dragged into a possible conflict. The UAE and Saudi Arabia, who support U.S. policy against regional foe Iran, have called on the international community to safeguard maritime trade and security of global oil supplies.

So far, only Britain has officially said

cial vessels in Gulf waters under a U.S. proposal to secure oil shipping lanes following attacks on tankers, its envoy to the United Arab Emirates said on Tuesday.

"If there happens to be a very unsafe situation we will consider having our navy escort our commercial vessels," Ambassador Ni Jian told Reuters in Abu Dhabi.

We are studying the U.S. proposal on Gulf escort arrangements," China's embassy later said in a text message.

The Chinese ambassador said the agreement could lead to cooperation on tackling terrorism and intelligence sharing, adding that further discussions would take place.

U.S. President Donald Trump said in a June 24 tweet that China, Japan and other countries "should be protecting their own ships" in the Gulf region, where the U.S. Navy's Fifth Fleet is based in Bahrain.

It was not clear if Washington had made an official request to Beijing, which has had to tread softly in the Middle East due to its close energy ties with both Iran and Saudi Arabia.

China has traditionally played a small role in Middle East conflicts or diplomacy despite its reliance on regional oil, but has increased its profile under President Xi Jinping.

Djibouti, has participated in regional escort missions in the Gulf of Aden and off the Somali coast as part of a UN Security Council anti-piracy mandate.

Britain joins US naval mission in Gulf

Britain is joining the U.S. in the U.S.planned naval mission in the Gulf to protect international shipping, following a series of tanker seizures by the Iranian military, in a move reflecting the escalating security crisis in the region.

Two Royal Navy warships already in the area will be working alongside two U.S. ships to accompany vessels through the Straits of Hormuz, which carries 20 per cent of the world's oil supplies.

Whitehall officials insisted the mission will not remain under U.S. control and, in time, will transition to one with European command in which the UK has offered to lead one of the Maritime Task Groups.

The new government under Boris Johnson will not change its stance towards Iran and will back, not follow, Donald Trump's administration.

U.K. continues to stand by Iran's agreement with international powers, they stressed, and will not follow the U.S. in imposing sanctions against Iran.

France and Germany, have expressed unwillingness to join a task force led by the Americans.

The U.K. decision to join the mission comes three weeks after a British flagged tanker, Stena Impero, was taken over by Iran's Revolutionary Guards. That followed the capture of an Iranian owned tanker, Grace 1, by Royal Marines off Gibraltar. Iran has repeatedly complained about the British seizure of Grace 1 and demanded the release of its crew and cargo.

Two British war ships - the destroyer HMS Duncan and frigate HMS Montrose - will continue to accompany UK-flagged and international shipping and two U.S. cruiser-destroyers, stationed at each end of the Straits of Hormuz, will protect British ships when called upon.

The two countries will operate, for the time being, under different rules of engagement.

Ben Wallace, the UK defense secretary, said: "The deployment of the Roval Navv assets is a sign of our commitment to our UK-flagged vessels and we look forward to working alongside the U.S. and others to find an international solution to the problems in the Strait of Hormuz.

Since time immemorial, women who rebel against what is considered normal by society-even unintentionally-have been labelled as unnatural, weird, wicked, and dangerous. What is surprising is the extent to which this kind of myth and prejudice has persisted throughout the centuries and still colours the world we live in," Jolie wrote.

The actor-humanitarian reflected on how often women who run for political office in democratic countries are described as witches.

"Bring together a group of strong women, and before too long someone will brand them a 'coven' the technical term, to be clear, for a gathering of witches meeting at night to consort with the devil. Women who stand up for human rights in many countries are still labelled 'deviant', 'bad mothers', 'difficult' or 'loose'," she wrote.

Jolie, 44, said the accusation of witchcraft has been used to control and silence women in almost all societies and in every century.

'Women could be accused of witchcraft for having an independent sex life, for speaking their mind on politics or religion, or for dressing differently. Had I lived in earlier times, I could have been burnt at

Australia floors England in First Test

Steve Smith gave a fine display as he hit century in both innings of the first Ashes Test against the host England which led to a dramatic win for the Australians at Edgbaston.

The England team which is fresh from its World Cup victory came a cropper in the Test as it failed to restrict Australian team for less than 200 runs. At one stage the Australian team was really struggling when it lost eight wickets for less than 120 runs. The England bowlers including Ben Stokes failed to deliver the goods as Australian team went on to score 284 runs in the first inning.

A swashbuckling hundred from comeback player Steve Smith with a tailander enabled the Aussies to make a fine recov-

The hosts had a horrific start in the fourth innings after losing as many as four wickets for only 12 runs and lost the match to their traditional rival by 257 runs.

There are some interesting sidelights to the show as Moeen Ali, the England all rounder lost his wicket to Lyon for ninth time in the Ashes series. He seems to be having a dreaded time against Lyon as he is yet to find an answer to his wiles and guiles. The English skipper Joe Root survived two Leg Before Wicket decisions and the West Indian umpire Joel Winson was the culprit.

The Aussie Captain Tim Paine was all praise for Smith and paid him handsome compliments.

The English pace attack led by James Anderson, Stuart Broad and Ben Stokes was handled with ease by the Aussie batsman especially Steve Smith and in the end the spin and pace duo of Lyon and Cummins came out in flying colors to de-

Across State Kyrgios falls at first hurdle in Montreal

Montreal

Nick Kyrgios crashed back to earth with a first-round loss at the ATP Montreal Masters on Tuesday, a 6-3, 6-4 victim Briton Kyle Edmund.

Two days after winning the ATP 500 series title in Washington with a burst of consistent form, the Australian court jester was unable to maintain momentum in a match delayed for 90 minutes in the second set by light rain.

"I'm a little bit tired. Physically I actually feel like I'm OK," Kyrgios said after losing in 67 minutes of actual play.

"Kyle played well, served well and didn't really give me any rhythm into the match at all." With top seed Rafael Nadal due to open his campaign on Wednesday, third seed and 2017 champion Alexander Zverev led the way into the third round, battling to contain Cameron Norrie before dispatching the Brit 7-6 (7/4), 6-4.

"I have great memories here from two years ago, and I've never lost in Montreal," Zverev said.

"I hope it stays that way." Kyrgios, who has come under fire for his inconsistency, had been hoping to build on his Washington success in Montreal.

"Tonight was challenging, I was actually really looking forward to playing," he said. "But I just got beaten by a better player today." Edmund, who won the opening set and stood 4-all in the second when players returned to the court, broke immediately and served out victory.

"It felt good," he said after striking 35 winners to 14 for Kyrgios. "He's a tricky player.

"I was watching for his underarm serve and he bluffed me once on that.

"You just cannot predict what he will do. I could only concentrate on my side and play my game.'

Kyrgios has returned to the Top 30 for the first time since last October as a result of his solid week in the US capital.

His loss was the third of the day for Australians, with Brit Daniel Evans defeating Alex de Minaur 6-4, 7-6 (8/6) and 12th seed John Isner rallying past Jordan Thompson 3-6, 6-3, 7-6 (8/

The Indian opener Rohit Sharma who is also the vice captain continued from where he left off in the World Cup and contributed his mite for his team.


Captain Virat also joined the party and especially played a crucial inning in the last match which resulted in three-zero washout.
